

**HOW IT WORKS**

- Submit the online form with your referrer and referral details;
- A Certified Tracking Solutions Fleet Specialist will contact you to learn more about your referral;
- If the referral is qualified, you will be requested to send an email introduction to the company being referred with contact information that Certified Tracking Solutions will supply to you;
- Should your referral become a Certified Tracking Solutions customer, you will receive a one-time referral reward of up to \$2,000\*.

**TERMS**

"Referrer" means the person making the referral to Certified Tracking Solutions.

**CONDITIONS**
